Summary 1

1 Summary

1.1 This document looks at commitments for housing within West Berkshire Council at 31 March 2011 and housing delivery over the period 1 April 2010 to 31 March 2011.

1.2 Net homes completed during the year totalled 199 (244 gross). This includes 31 new affordable homes. At 31 March 2011 there were 3,671 outstanding hard commitments for housing, that is dwellings with planning permission that were either under construction or not yet started. These include the development at Newbury Racecourse where outline permission has been granted for up to 1,500 dwellings.

1.3 Table 1 shows completions, dwellings starts and new permissions granted during the year. Though net completions were low for 2010/11, the indications are that housing delivery will be higher in 2011/12.

2 Introduction

2 Introduction

2.1 This document summarises the results of the 2011 survey of planning commitments for housing in West Berkshire carried out by West Berkshire Council. The residential commitments exercise aims to monitor dwelling gains and losses from all sources, including new development and changes to the housing stock arising from conversions, demolitions and changes of use. All sites which were in some way committed for housing development at 31 March 2011 are included in the survey.

2.2 Surveys of housing commitments have been produced annually for the Berkshire area since 1976. Information relating to conversions, demolitions and changes of use has been included since 1994.

2.3 The Joint Strategic Planning Unit undertook the commitments exercise for West Berkshire between 1998 and 2010. Prior to this, the Berkshire County Council produced the statistics.

2.4 Section 6 of this report contains the summary tables. Detailed schedules of individual housing sites are found in Sections 7 to 9. These are divided into large, medium and small sites:

- Large sites are sites of 1 hectare or more.
- Medium sites are sites of less than 1 hectare with 10 or more dwellings (gross) permitted.
- Small sites are sites of less than 1 hectare with under 10 dwellings permitted.

Definitions of Terms used in Schedules

Term	Definition
Dwelling	<p>A dwelling is defined as a self-contained unit of accommodation in line with the 2001 Census definition. Non self-contained household spaces at the same address are counted together as a single dwelling.</p> <p>Non permanent (or temporary) dwellings, such as mobile homes, are included if they are the occupant's main residence. Communal housing such as nursing homes or hospital staff accommodation are not counted in the overall housing supply.</p>
New Build (NB)	Construction of new housing stock
Demolition (D)	Loss of housing stock through demolition of existing residential property
Conversion (C)	Alteration of an existing residential use to form a different number of self-contained units(e.g. Conversion of a single dwelling house into three flats).
Change of Use (COU)	Replacement of existing residential use by a non-residential use or vice versa (e.g. Conversion of barn into a dwelling or retail unit to flat)
Previously Developed Land/ Greenfield (PDL/GF)	<p>Previously developed land is defined in Annex B of Planning Policy Statement 3: Housing (June 2011) as follows:</p> <p>"Previously developed land is that which is or was occupied by a permanent structure, including the curtilage of the developed land and any associated fixed surface infrastructure."</p> <p>The definition includes defence buildings, but excludes:</p> <ul style="list-style-type: none"> • Land that is or has been occupied by agricultural or forestry buildings. • Land that has been developed for minerals extraction or waste disposal by landfill purposes where provision for restoration has been made through development control procedures. • Land in built-up areas such as private residential gardens, parks, recreation grounds and allotments, which, although it may feature paths, pavilions and other buildings, has not been previously developed. • Land that was previously developed but where the remains of the permanent structure or fixed surface infrastructure have blended into the landscape in the process of time (to the extent that it can reasonably be considered as part of the natural surroundings). <p>Before June 2010, the definition of previously developed land did not specifically exclude private residential gardens. The commitments exercise includes the classification of a permission according to whether or not it involves previously developed or greenfield land. Sites have been classified according to the definition of previously developed land that existed at the time of the grant of planning permission i.e:</p>

Term	Definition
	<ul style="list-style-type: none"> Permissions granted before 9 June 2010 have been classified according to the previous definition of previously developed land. Sites involving the curtilage of private residential gardens have been classified as previously developed land. Permissions granted since 9 June 2010 have been classified as previously developed land or greenfield in accordance with the following guideline: Where development involves the demolition of an existing dwelling (or number of dwellings) and its replacement with a scheme involving development (structures) partly on the footprint of a former property, the site is classified as previously developed land where 50% or more of the proposed footprint is on the footprint of former property. In all other instances, i.e. where less than 50% of the proposed footprint is on the footprint of a former property, the land is regarded as greenfield, and is shown as GF/RG in the schedules.
Commitment	<p>There are two types of commitment:</p> <ul style="list-style-type: none"> Hard commitment - dwellings on a site which has the benefit of a valid planning permission. Soft commitment - dwellings on a site which has no formal planning permission but which has been identified in principle as being suitable for development. Soft commitments are further divided into two categories: a site which has been identified in a Development Plan document(DPD) but which has yet to receive planning permission; and a site where the principle for development has been accepted through a formal resolution of the local authority, but where the signing of a legal agreement is awaited before planning permission is issued. Sites identified through the Local Development Framework process are only included when the DPD has been submitted to the Secretary of State. Any future application on a site that has been accepted in principle will be considered on its individual merits by the local planning authority
Outstanding commitments	These are the total number of dwellings committed that are either under construction or not started at the time of the survey. Once a dwelling is complete it is no longer an outstanding commitment.
Affordable Housing	Affordable housing is defined in Planning Policy Statement 3 Housing (June 2011). Affordable housing includes social rented, affordable rented and intermediate housing, provided to specified eligible households whose needs are not met by the market.
Rural Exception Schemes	Housing schemes to meet local need in rural areas that may be permitted in areas that would not normally be acceptable for residential development.
Full application (FUL)	This gives details of the uses proposed and the form and appearance of the development i.e. Materials, design, access and layout details. Full permissions normally last for three years.

Term	Definition
Outline application (OUT)	This is used to establish the general principle of a particular kind of development on a site. Outline permission normally lasts for three years but cannot be acted upon until full details have been approved under a subsequent "reserved matters" application.
Reserved matters application (REM)	This is a submission for approval of details following an outline approval.

4 Methodology

4 Methodology

4.1 Housing commitments are updated every year in the following way:

- All outstanding commitments from the last survey are identified.
- Relevant planning permissions granted between 1 April and 31 March of the current survey year are added to the list of outstanding commitments from the previous year.
- All sites are visited by officers from the Council, in order to obtain progress data.
- Survey information is analysed, tables and schedules prepared for publication.

Format of detailed Schedules of Housing Sites

4.2 The detailed schedules contain the following information

- Parish
- Site Address
- Planning application number (* denotes a new permission during the current monitoring year but only where there has not been a previous housing commitment)
- Previously developed land (PDL)/ Greenfield (GF) - see definition in Section 3 for clarification)
- Number of dwellings permitted, expressed in terms of new build, demolitions, conversions and changes of use, and net figures
- Number of net dwellings completed on the site as at March 2011
- Net completions during the monitoring year 2010/11
- Number of dwellings under construction at 31 March 2011
- Dwellings not started (net)
- Dwellings outstanding (yet to be completed) at 31 March 2011(net)

Development Trends 5

5 Development Trends


5.1 Table shows the delivery of housing in West Berkshire since 1991. The housing requirement set out in the South East Plan for the period 2006 - 2026 is for an average of 525 net additional units per annum. The national economic downturn has resulted in fewer completions in the last two years but overall the housing requirement for the period since 2006 has been met.

5.2 Figure 1 shows the annual housing delivery since 1991. Completions were high in the period from 2004 to 2007 partly due to delivery of Local Plan Housing sites. Delivery in 2010/11 is the lowest recorded but the levels of housing under construction (534 dwellings at 31 March 2011) indicate that the 2011/12 figure will be significantly higher.






Housing Commitments for Burghfield Common


Housing Commitments for Chieveley




Housing Commitments for Hampstead Norreys






Housing Commitments for Kintbury



Housing Commitments for Lambourn




Housing Commitments for Padworth


Housing Commitments for Pangbourne






Housing Commitments for Theale






