I am emailing today my objection to the latest proposed local development plan for Pincents Hill.

This is total madness to think 138 houses would be suitable for this site east of Pincents Hill. This site would put much more pressure on the roads around sainsburys, ikea and other offices located in the area. Have any of the developers/planning committee actually been stuck in the regular traffic jams trying to leave sainsburys and ikea? My husband has had to leave the car in the car park and go back for it later after queuing and not moving on the worst occasion (for him) for over an hour. Especially with the amount of change to stamp duty from April.

Why should they be evicted from their homes just so this land can be developed by greedy developers wanting to ruin all of our green space?
